

The terms of reference are as under:

- To review the work done by the Council in the area of drug standardization, clinical research and drug proving as presented by the Chairman of the Special Committees. They may undertake such visits as the Director of the Council and reviewed by the Chairman of SAC, may decide to have an on the spot study of the work being done.
- To prioritize new areas of work which should be given a focus by the Council and its units for which detailed targets and strategies would be suggested by the Chairman of the Special Committees.
- To suggest ways for forging linkages with other institutions in the respective fields including allopathic institutions with a view to mounting clinical trials which can determine efficacy of the drugs and therapies. The SAC will also determine the areas which could lead to significant impact on the health scene, keeping in mind epidemiological and demographic factors and gaps that exist in the current provision of health care which can be filled through Homoeopathic Medicine.
- To suggest areas where matters should be taken forward for either patentization, marketing or for further collaborative research including the broad course of action to be pursued.
- To suggest broad funding/ pattern of assistance to enable the identified work to proceed in a cost-effective, time-bound and result-oriented fashion.
- To recommend dropping of projects or revamping of projects/items of work keeping in mind the interest of best developing the sector in a reasonable time frame.


