

**Proceeding of the Meeting of Board of Studies (BoS) for 1<sup>st</sup> Homoeopathy (MD) Examination 2023-24 held on 25/11/2025 at 11:30 AM at the VC's Board Room, OUHS, Bhubaneswar.**


The Meeting of Board of Studies of Homoeopathy (MD) for Part-I Examination, 2023-24 was held on 25/11/2025 at 11:30 AM in the VC's Board Room at OUHS, Bhubaneswar in presence of the member as per attendance sheet at Annexure-1. After detail discussion on the Agenda Points the following decisions were taken: -

1. Committee at the beginning selected **Dr. Laxmikanta Nanda**, Ex-Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College & Hospital Bhubaneswar as the Chairperson.
2. The MD Homoeopathy course was approved as per the guidelines of the **National Commission for Homoeopathy (NCH)** for 2024-25 Batch onwards and the **Central Council of Homoeopathy (CCH)** for 2023-24 Batch.
3. There will be **single evaluation** of answer scripts. All **four examiners** shall jointly assess the candidate's performance and recommend the result (Pass/Fail) to the University.
4. The Homoeopathy Part-I Examination 2023-24 will be held in the **last week of December 2025**. Necessary processing for the examination will begin in the **last week of November 2025**.
5. Members of the Board of Studies shall submit the list of **Question Setters, Examiners, and Evaluators** for the Part-I Examination 2023-24.
6. The Practical Examination will be conducted by at least two internal and two external examiners. Among the internal examiners, one must be the Guide, as per CCH guidelines.
7. The valuation zone for the examination will be Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar. The evaluation of answer scripts will be carried out by the examiners during the Practical Examination period.
8. The Homoeopathy Part-I Examination 2023-24 will be conducted at the **respective colleges**.



9. The pass/fail criteria for Homoeopathy Part-I Examination will follow CCH and OUHS regulations. A minimum of 50% marks in both theory and practical is required to pass in the examination.
10. No grace marks shall be awarded in the Homoeopathy Part-I Examination.
11. The revised practical marking system (including Practical/Clinical, Viva, and Internal Assessment) will be **implemented from the 2024–25 batch onwards**.
12. Colleges will be issued letter for submission of internal assessment marks of 1<sup>st</sup> term test and 2<sup>nd</sup> term test on or before 31<sup>st</sup> December 2025.
